Notification of the terms of the Decision DC23175 - QAFCON – 23.10.2024 of the CAF Disciplinary Board

Re: Protest Over Match No. 87 Libya vs Nigeria scheduled to be held on 15 October in Benghazi - African Cup of Nations 2025 Qualifiers.

Mr. General Secretary,

Please find the terms of the decision rendered by the CAF Disciplinary Board at its meeting on the 23rd of October 2024. The CAF Disciplinary Board was composed of:

I. DECISION:

CAF Disciplinary Board decides:

- 1. The Libya Football Federation is found to have breached Article 31 of the African Cup of Nations Regulations as well as Articles 82 and 151 of the CAF Disciplinary Code.
- 2. The match No.87 Libya v. Nigeria of the CAF African Cup of Nations Qualifiers 2025 (scheduled to be played on 15 October 2024 in Benghazi) is declared lost by forfeit by Libya (by a score of 3-0).



- 3. The Libya Football Federation is ordered to pay a fine of USD 50,000.
- 4. The fine is to be paid within 60 days of notification of the present decision.
- 5. All other and further motions or prayers for relief are dismissed.

I. NOTE RELATED TO THE FINDINGS OF THE DECISION

Should any of the parties wish to receive the grounds of the decision, a written request must be received by CAF, within ten (10) days of receipt of notification of the findings of the decision. Failure to do so within the stated deadline will result in the decision becoming final and binding and the parties being deemed to have waived their rights to file an appeal.

II. LEGAL ACTION

This decision may be contested before the CAF Appeal Board. The party intending to appeal shall announce their intention in writing within three (3) days of notification of the grounds of the decision.

Reasons for the appeal shall be given in writing within a further time limit of seven (7) days, commencing upon the expiry of the first-time limit of three (3) days. The deposit mentioned in article 58 of the CAF Disciplinary Code must be paid to CAF's account. The appeal is invalid without the relevant deposit within the relevant time limit.

The appeal does not have a suspensive effect except with regard to orders to pay a sum of money (Article 59 CAF Disciplinary Code).

III. NOTE RELATING TO THE PAYMENT OF THE FINE
